

**WILDLIFE AND COUNTRYSIDE ACT 1981**

**Hertfordshire County Council**  
**(Hunsdon 3)**  
**Modification Order 2024**

This Order is made by Hertfordshire County Council under Section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that the Definitive Map and Statement of Public Rights of Way in Hertfordshire require modification in consequence of the occurrence of an event specified in Section 53(3) (c)(i),(ii), (iii) of the Act, namely, the discovery by the authority of evidence which (when considered with all other relevant evidence available to them) shows:

- (i) that a right of way which is not shown in the map and statement subsists or is reasonably alleged to subsist over land in the area to which the map relates, being a right of way such that the land over which the right subsists is a public path, a restricted byway or, subject to section 54A, a byway open to all traffic
- (ii) that a highway shown in the map and statement as a highway of a particular description ought to be there shown as a highway of a different description
- (iii) that there is no public right of way over land shown in the map and statement as a highway of any description, or any other particulars contained in the map and statement require modification.

The authority has consulted with every local authority whose area includes the land to which the Order relates. Hertfordshire County Council hereby order that:

1. For the purposes of this Order the relevant date is 22<sup>nd</sup> March 2024.
2. The Definitive Map and Statement of Public Rights of Way in Hertfordshire shall be modified as described in Part I and Part II of the Schedule and shown on the plan forming part of this Order ("the Order Plan").
3. This Order shall take effect on the date it is confirmed and may be cited as the Hertfordshire County Council (Hunsdon 3) Modification Order 2024.

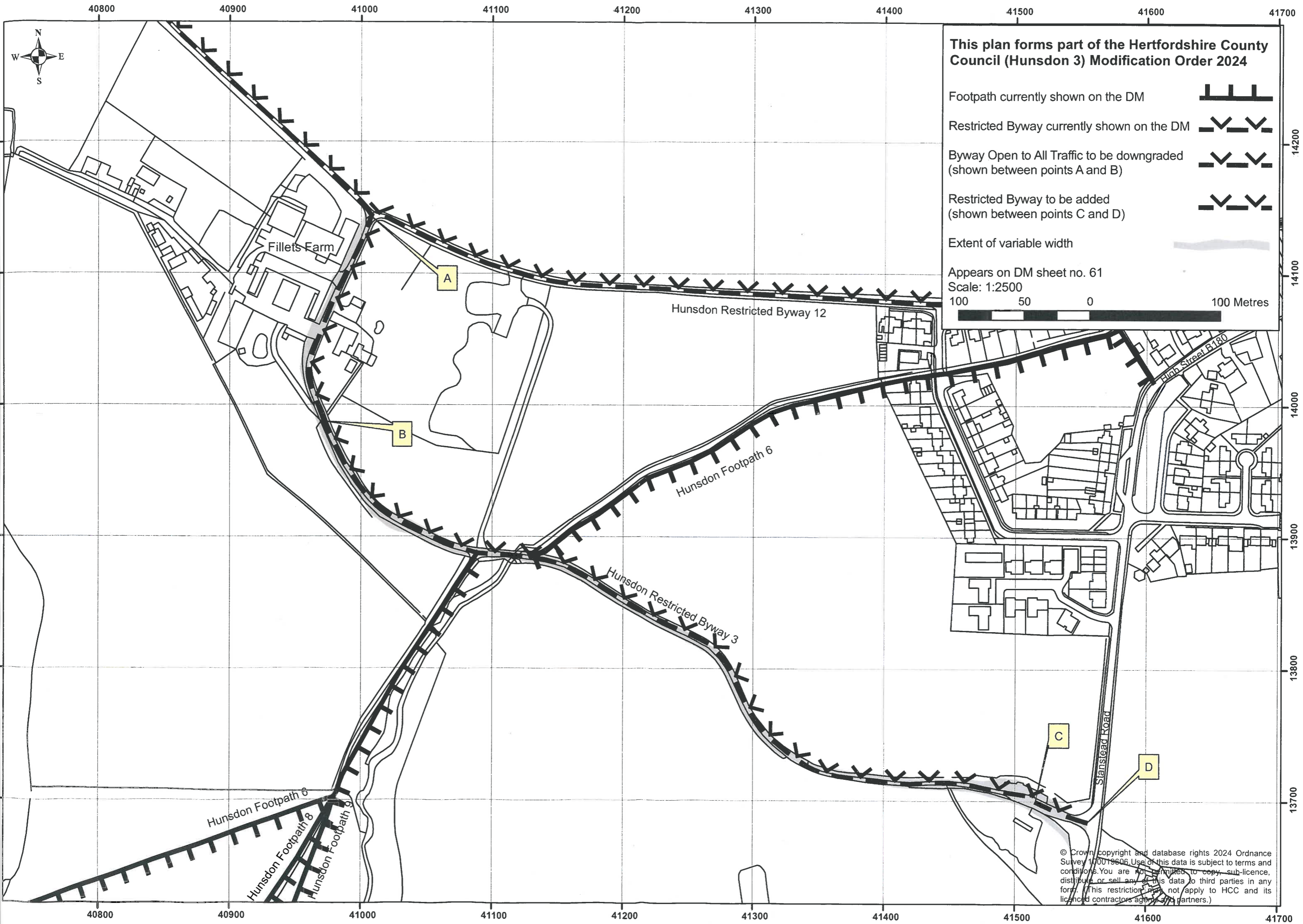

PART I  
Modification of Definitive Map**

**DESCRIPTION OF PATH OR WAY TO BE ADDED**

A public Restricted Byway commencing from Hunsdon Restricted Byway 3 at TL 4151 1370 (point C on the Order Plan) and then running east south east for approximately 40 metres to a junction with Stanstead Road (public highway) at TL 4155 1368 (point D on the Order Plan)

Width: Varies between 4 metres and 16 metres as shown shaded grey on the Order Plan

Limitations: None

**DESCRIPTION OF PUBLIC RIGHT OF WAY TO BE DOWNGRADED**

That part of Hunsdon 3 currently recorded on the Definitive Map as Byway Open to All Traffic to be downgraded to a Restricted Byway commencing from Hunsdon Restricted Byway 12 at TL 4100 1414 (point A on the Order Plan) and then running generally south south west past Fillets Farm for approximately 170 metres to TL 4097 1398 (point B on the Order Plan)

Width: Varies between 7 metres and 11 metres as shown shaded grey on the Order Plan

Limitations: None

**VARIATION OF PARTICULARS OF PATH OR WAY**

The Statement for Hunsdon 3 shall be amended as follows:

003	RB	HCC 61

Commences from RB 12 at TL 4100 1414 then SSW past Fillets Farm for approx. 130m then SE for approx. 740m, passing two junctions with FP 6 (to S, then to N), then continuing to meet Stanstead Road (public highway) at TL 4155 1368

**Width** Varies between 4m and 18m as shown in the Hertfordshire County Council (Hunsdon 3) Modification Order 2024

**Limitations** None
