# Council Data Privacy Policy

## Privacy Notice

When you contact Hunsdon Parish Council the information you provide (personal information such as name, address, email address, phone number) will be processed and stored so that it is possible to contact you and respond to your correspondence, advise, provide information, or send invoices and receipts relating to service provision.

Your personal information will not be shared with any third party without your prior consent.

## Hunsdon Parish Council Right to Process Information

GDPR Article 6 (1) (a) (b) and (c) apply:

Processing is with consent of the data subject

or

Processing is necessary for compliance with a legal obligation

or

Processing is necessary for the performance of a contract with the data subject or to take steps to enter into a contract

## Information Security

Hunsdon Parish Council takes care to ensure the security of personal data. We make sure that your information is protected from unauthorised access, loss, manipulation, falsification, destruction or unauthorised disclosure. This is done through appropriate technical measures and relevant policies.

We will only keep your data for the purpose it was collected for and only for as long as is necessary, after which it will be deleted or shredded.
